Looked at conditioner, bottom roller was snapped in half, new used roller was on car hauler.

cut old bearing inner races off the roller from wrecker with torch while roller was on the trailer.

Removed the drive sprocket from bottom roller with puller, removed lock collars but could not remove bearings, torched both bearings out of the bottom roller flanges.

Tried to install the bottom roller but there was no possible way it could be installed with moco in one piece.

Checked the tech manual and seen there was steps to separate the back of conditioner from the cutter platform. (these steps were not listed on the computer tech manual, which is why the job was easier said than done as it was unknown that the moco needed to be split.)
Followed the steps in manual to split platform from rest of the conditioner.

parts were seized on, had to bead with torch to loosen, cut wiring harness for lights as there was no plug, set knives between guards removed float springs, removed frame pins and backed the conditioner away from platform.

Inspected bearings in top roller, they were noisy and had vibration, talked to customer and he agreed to change them as well. Did not have enough parts and it was late in the evening, packed truck and went back to shop.

Next day friday july 29

Picked extra 2 bearings lock collars, flange sets and some bolts

Traveled to location

Finished cutting Left hand bearing off top roller, removed the roll pressure arm from left hand side of conditioner installed lower roller with new bearings flanges and lock collars to the position old roller was at. Installed the roll pressure arm and top roller bearing on the lh side, used old flanges and lock collar.

Tried to remove the drive sprocket from rh side of top roller, was seized on the shaft.

heated to red hot multiple times and tried to pull off with puller, the puller would not remove sprocket.

customer went to preeceville salvage to get new drive sprocket. cut old sprocket off with torch until the sprocket could slide off. Installed new bearing in top rh side of roller, used old flange and lock collar, set to previous setting, installed the new top sprocket when customer returned

tried to install the bottom sprocket but ti would not go on shaft, cleaned shaft and sprocket splines but could not get it to fit, customer returned sprocket to salvage earlier that day as we thought it would not be needed.

Customer went back to salvage and picked up sprocket.

While waiting for customer to return hooked the conditioner back up to platform, installed lock pins tilt cylinder, fixed cut wiring Inspected timing on knife drives, timing was out, removed the rh drive belt, set timing and reinstalled belt

Customer returned, installed the drive sprocket, one idler sprocket was loose so tightened the jam bolts on that, installed drive chain Adjusted the roller pressure arms as per directions in book

(customer installed float springs and set to previous tension while installed chain and set the roller pressure.

Ran the conditioner, adjusted the roller pressure as good as possible, top roller has a slight bend so it still has some vibration when no load in rollers, checked roller timing was good.

packed up service truck while customer tested conditioner in field, checked in with customer, conditioner is working better than it was before the roller broke.

traveled back to shop
